The functions of the Embassy <i>inter alia</i> include political and economic cooperation, trade and investment promotion, scientific &amp; technological cooperation, cultural interaction, press and media liaison, and consular operations including PIOs/NRIs, in bilateral and multilateral contexts.</li></ul>

(ii)	Powers and Duties of Officers and employees	<ul style="list-style-type: none"> <li>- General Administrative powers are derived from IFS (PLCA) Rules, as amended from time to time.</li> <li>- Financial powers of the Officers of the Embassy of India have been detailed in the Delegated Financial powers of the Government of India Representatives Abroad.</li> <li>- Other powers are derived from the Passport Act of India, Visa Manual and Consular Manual or delegated by the Ministry of External Affairs.</li> <li>- The Officers of the Embassy function under the guidance and supervision of the Ambassador.</li> </ul>
